

CONSTITUTION OF THE DELAWARE STATE ARCHERY ASSOCIATION

Revision, November 2017

ARTICLE I : NAME

1. *THE NAME OF THE ASSOCIATION SHALL BE THE "DELAWARE STATE ARCHERY ASSOCIATION", INDICATED IN ABBREVIATION AS D.S.A.A.*

ARTICLE II : PURPOSE

1. *THE PURPOSE OF THE D.S.A.A. SHALL BE :*
 - A. *TO FOSTER, EXPAND, AND PERPETUATE THE PRACTICE OF ARCHERY IN DELAWARE.*
 - B. *TO FOSTER AND PERPETUATE A FEELING OF GOOD FELLOWSHIP AMONG ALL ARCHERS.*
 - C. *TO ENCOURAGE THE USE OF THE BOW IN THE HUNTING OF ALL LEGAL GAMES BIRDS AND ANIMALS, AND TO PROTECT, IMPROVE, AND INCREASE THE PRIVILEGE OF BOW AND ARROW HUNTERS.*
 - D. *TO PROMOTE VARIOUS TYPE OF BOW AND ARROW GAMES AND ADOPT AND ENFORCE REGULATIONS, CONDITIONS, AND METHODS OF PLAYING THE GAME.*
 - E. *TO COOPERATE WITH THE FEDERAL AND STATE GOVERNMENTS AND SPORTSMEN AND CONSERVATION ORGANIZATIONS IN THE PROPAGATION AND CONSERVATION OF GAME AND ITS NATURAL HABITAT.*
 - F. *TO CONDUCT A CONTINUOUS AND EDUCATIONAL PROGRAM DESIGNED TO ACQUAINT THE PUBLIC WITH ARCHERY AND ITS USE AS A PRACTICAL AND HUMANE WEAPON, SUITABLE UNDER PROPER REGULATIONS, FOR THE HUNTING OF GAME ANIMALS AND BIRDS.*
 - G. *TO COOPERATE WITH TARGET ARCHERY ORGANIZATIONS, NATIONAL, STATE, AND LOCAL, IN FOSTERING AND PERPETUATING THE USE OF THE BOW.*

ARTICLE III : MEMBERSHIP

1. *THERE SHALL BE FIVE (5) TYPES OF MEMBERSHIP – HONORARY, LIFETIME, ACTIVE, ASSOCIATE, AND CLUB*
 - A. *HONORARY MEMBERSHIP, WITH EXEMPTION FROM DUES AND VOTING RIGHTS, MAY BE GRANTED FOR EXCEPTIONAL MERIT AND SERVICE, UPON A 3/5 VOTE OF THE STATE COMMITTEE.*
 - B. *LIFETIME MEMBERSHIP, WITH EXEMPTION FROM REGULAR FEES AND DUES ESTABLISHED FOR D.S.A.A., WILL BE GRANTED TO AN INDIVIDUAL OR FAMILY (INCLUDING UNMARRIED CHILDREN UNDER 18 YEARS OF AGE) UPON APPLICATION AND PAYMENT OF A FEE EQUAL TO TWENTY FIVE (25) TIMES A SINGLE ACTIVE MEMBERSHIP DUES. THIS MEMBERSHIP MAY BE APPLIED FOR ONLY BY RESIDENTS OF DELAWARE BUT, ONCE GRANTED, WILL REMAIN IN EFFECT REGARDLESS OF RESIDENT STATUS. TOURNAMENT PARTICIPATION SHALL BE IN ACCORDANCE WITH ARTICLE III, SECTION 6, OF THE BY-LAWS.*

- C. ACTIVE MEMBERSHIP WILL BE GRANTED TO ANYONE WHO IS A BONAFIDE RESIDENT OF THE STATE OF DELAWARE OR WHO'S HOME CLUB IS A D.S.A.A. APPROVED ARCHERY CLUB WITHIN THE STATE UPON APPLICATION AND PAYMENT OF REGULAR FEES AND DUES.
 - D. ASSOCIATE MEMBERSHIP SHALL BE GRANTED TO ANYONE WHO IS NOT A RESIDENT OF DELAWARE UPON APPLICATION AND PAYMENT OF REGULAR FEES AND DUES. THEY SHALL BE NON-VOTING MEMBERS.
 - E. CLUB MEMBERSHIP SHALL BE CONFERRED ON ANY REGULAR ORGANIZED ARCHERY CLUB, 1/2 OF WHOSE MEMBERS ARE EITHER RESIDENTS OF THE STATE OF DELAWARE, OR DELAWARE NFAA MEMBERS, UPON APPLICATION AND PAYMENT OF REGULAR FEES AND DUES.
2. LOSS OF MEMBERSHIP
- A. FAILURE TO PAY MEMBERSHIP FEES WITHIN THE DEADLINES ESTABLISHED BY THE D.S.A.A.
 - B. FAILURE TO ABIDE BY THE RULES, REGULATIONS, AND POLICIES OF THE D.S.A.A.
 - C. IF EXPULSION OR SUSPENSION IS REQUIRED, THE FOLLOWING STEPS WILL BE TAKEN ;
 - (1) UPON PRESENTATION OF EVIDENCE OF CAUSE OF ACTION, THE EXECUTIVE COMMITTEE WILL PRESENT SPECIFIC CHARGES TO THE SUBJECT MEMBER.
 - (2) THE MEMBER WILL HAVE THIRTY (30) DAYS, FROM DATE OF EXECUTIVE COMMITTEE PRESENTATION OF CHARGES, TO PREPARE A DEFENSE OR CORRECT THE DEFICIENCY.
 - (3) AT THE END OF THE 30 DAY PERIOD, THE EXECUTIVE COMMITTEE WILL RE-EXAMINE THE CASE. IF THE EVIDENCE WAS NOT VALID OR THE DEFICIENCY IS BEING CORRECTED, THE MATTER WILL BE DROPPED. IF THE EVIDENCE WAS VALID OR NO STEPS TO CORRECT THE DEFICIENCY HAVE BEEN INITIATED, THE CHARGES ALONG WITH THE EVIDENCE AND THE DEFENSE (IF SUBMITTED BY THE MEMBER) WILL BE IMMEDIATELY PRESENTED TO THE STATE COMMITTEE WITHIN NINETY (90) DAYS FROM THE TIME THAT THE EVIDENCE WAS FIRST PRESENTED TO ANY MEMBER OF THE EXECUTIVE COMMITTEE. THE STATE COMMITTEE WILL ACT ON THE MOTION WITHIN TWENTY EIGHT (28) DAYS FROM THE TIME IT WAS PRESENTED BY THE EXECUTIVE COMMITTEE.
3. REINSTATEMENT OF MEMBERSHIP AFTER EXPULSION OR SUSPENSION
- A. ACTION TO REINSTATE MEMBERSHIP SHALL BE SUSTAINED UPON APPROVAL OF 3/5 OF THE STATE COMMITTEE.

ARTICLE IV : STATE COMMITTEE

- 1. THE STATE COMMITTEE SHALL BE COMPOSED OF THE ELECTED D.S.A.A. OFFICERS, AS WELL AS TWO (2) D.S.A.A. MEMBERS IN GOOD STANDING FROM EACH D.S.A.A. APPROVED ARCHERY CLUB WITH CLUB MEMBERSHIP. IN THE EVENT THAT SAID CLUB MEMBERSHIP IS LACKING PARTICIPATION, THE STATE COMMITTEE SHALL BE COMPOSED OF, AT A MINIMUM, THE ELECTED D.S.A.A. OFFICERS.
- 2. THE METHOD OF SELECTING AND REMOVING MEMBERS OF THE STATE COMMITTEE SHALL BE THE APPROPRIATE CLUB'S RESPONSIBILITY.
- 3. THE TENURE OF OFFICE FOR EACH CLUB STATE COMMITTEE PERSON SHALL BE TWO (2) YEARS, EFFECTIVE JANUARY 1, WITH THE FOLLOWING EXCEPTION ; ONE OF THE INITIAL STATE

COMMITTEE PERSONS FROM EACH CLUB SHALL SERVE A TERM OF ONE (1) YEAR. FOR EACH SUCCEEDING YEAR, EACH CLUB SHALL SELECT ONE (1) D.S.A.A. MEMBER TO SERVE ON THE STATE COMMITTEE. CLUBS MAY DEVIATE FROM THE PROCEDURE WITH THE SPECIFIC APPROVAL OF THE D.S.A.A. EXECUTIVE COMMITTEE. REQUESTS FOR DEVIATIONS MUST BE PRESENTED TO THE D.S.A.A. ACTING SECRETARY NO LATER THAN SEPTEMBER 30. EACH ARCHERY CLUB SECRETARY, IN OCTOBER OF EACH YEAR, WILL INFORM THE D.S.A.A. SECRETARY, IN WRITING, THE NAME AND ADDRESS OF ITS SELECTED COMMITTEE PERSON, ALONG WITH THE CLUB'S SHOOT SCHEDULE FOR THE FOLLOWING YEAR.

4. THE STATE COMMITTEE SHALL BE THE VOTING BODY ON AMENDMENTS TO THE BY-LAWS OF THE D.S.A.A.
5. ON ALL QUESTIONS SUBMITTED TO THE STATE COMMITTEE FOR A VOTE, EACH COMMITTEE PERSON SHALL BE ENTITLED TO ONE (1) VOTE.
6. ALL QUESTIONS REQUIRING ACTIONS OF THE STATE COMMITTEE SHALL BE SUBMITTED BY THE SECRETARY OF THE D.S.A.A., BY MAIL, TO ALL MEMBERS OF THE STATE COMMITTEE. THE STATE COMMITTEE PERSONS SHALL POLL THEIR ELIGIBLE MEMBERS OF THEIR RESPECTIVE CLUBS AND SHALL SUBMIT THEIR FINDINGS, IN WRITING, TO THE SECRETARY WITHIN TWENTY EIGHT (28) DAYS OF RECEIPT OF THE BALLOT. AT THE END OF THE 28 DAY PERIOD, THE SECRETARY SHALL COUNT THE POPULAR VOTE IN THE PRESENCE OF THE PRESIDENT OF THE D.S.A.A. AND SUBMIT THE COUNT TO HIM. UNLESS OTHERWISE PROVIDED BY THE CONSTITUTION OR THE BY-LAWS, A MAJORITY OF THE ELIGIBLE VOTES RECEIVED SHALL DECIDE THE QUESTION. THE PRESIDENT SHALL THEN ADVISE THE CLUBS IN THE STATE DECLARING THE RESULTANT VOTE TO BE AN OFFICIAL ACTION OF THE STATE COMMITTEE.
7. QUESTIONS REQUIRING ACTIONS OF THE STATE COMMITTEE MAY BE PRESENTED IN EITHER OF TWO (2) WAYS ;
 - A. BY THE EXECUTIVE COMMITTEE AS A RESULT OF THEIR ADMINISTRATIVE DUTIES, OR ;
 - B. BY PETITION SIGNED BY A MINIMUM OF TWO (2) STATE COMMITTEE PERSONS AND PRESENTED TO THE EXECUTIVE COMMITTEE.
8. A QUORM OF THE STATE COMMITTEE SHALL BE 2/3 OF THE D.S.A.A. CLUBS.

ARTICLE V : EXECUTIVE COMMITTEE

1. THE EXECUTIVE COMMITTEE SHALL CONSIST OF A PRESIDENT, VICE PRESIDENT, SECRETARY TREASURER AND N.F.A.A. DIRECTOR.
2. ALL EXECUTIVE COMMITTEE PERSONS SHALL BE MEMBERS IN GOOD STANDING OF THE D.S.A.A. AND HAVE A HOME CLUB IN DELAWARE.
3. SUBJECT ONLY TO THE PROVISIONS OF THIS CONSTITUTION, AND SUCH ACTION AS MAY BE TAKEN FROM TIME TO TIME, THE EXECUTIVE COMMITTEE SHALL MANAGE THE ACTIVITIES AND POLICIES OF THE D.S.A.A.
4. THE EXECUTIVE COMMITTEE AND/OR THE STATE COMMITTEE SHALL MEET IN PERSON WHENEVER POSSIBLE AS DEEMED NECESSARY, AT THE CALL OF THE PRESIDENT.
5. AT ALL MEETINGS OF THE EXECUTIVE COMMITTEE, THREE (3) MEMBERS SHALL CONSITUTE A QUOROM.

6. *ACTIONS OF THE EXECUTIVE COMMITTEE MAY BE DECIDED BY MAIL.*
7. *THE PRESIDENT SHALL APPOINT ALL MEMBERS OF THE FOLLOWING STANDING COMMITTEES: TOURNAMENT, PUBLICITY, AND OTHER SPECIAL COMMITTEES HE CONSIDERS NECESSARY. THE CHAIRMAN OF EACH COMMITTEE SHALL PRESENT AN ANNUAL REPORT TO THE EXECUTIVE COMMITTEE AT THE MEETINGS ASSOCIATED WITH THE STATE CHAMPIONSHIP FIELD TOURNAMENT.*
8. *CORRESPONDENCE BETWEEN EXECUTIVE COMMITTEEMEN SHALL NOT BE REVEALED TO ANYONE NOT ON THE EXECUTIVE COMMITTEE WITHOUT PRIOR WRITTEN APPROVAL OF THE PARTY INVOLVED.*
9. *ANY ELECTED OFFICER OF THE D.S.A.A. MAY BE REMOVED FROM THE OFFICE BY A 2/3 VOTE OF THE STATE COMMITTEE. THE OFFICER INVOLVED, HOWEVER, SHALL HAVE EVERY OPPORTUNITY TO DEFEND THEMSELVES.*

ARTICLE VI : OFFICERS AND THEIR DUTIES

1. *THE OFFICERS OF THE D.S.A.A. SHALL BE A PRESIDENT, VICE-PRESIDENT, SECRETARY, TREASURER, AND A D.S.A.A. DIRECTOR.*
2. *THE PRESIDENT SHALL PRESIDE AT ALL MEETINGS OF THE EXECUTIVE COMMITTEE AND/OR STATE COMMITTEE.*
3. *IF THE PRESIDENT IS UNABLE TO ACT, THE VICE PRESIDENT SHALL PERFORM THE PRESIDENT'S DUTIES*
4. *THE SECRETARY SHALL; KEEP ALL RECORDS OF THE D.S.A.A. EXECUTIVE AND STATE COMMITTEES, SERVE NOTICES OF MEETINGS, CONDUCT CORRESPONDENCE, HANDLE BALLOTING AND INFORM THE D.S.A.A. MEMBERSHIP OF OFFICIAL ACTIONS OF THE STATE AND EXECUTIVE COMMITTEES.*
5. *The TREASURER SHALL HANDLE ALL MONIES OF THE D.S.A.A., AND DEPOSIT THEM TO THE CREDIT THEREOF. THE TREASURER SHALL BE AUTHORIZED BY THE PRESIDENT TO HANDLE WHAT MONEY IS NECESSARY TO CARRY OUT THE DUTIES OF THE OFFICE*

ARTICLE VII : ELECTION – TERM OF OFFICE

1. *ALL EXECUTIVE COMMITTEEMEN SHALL SERVE FOR A PERIOD OF TWO (2) YEARS, BEGINNING JANUARY 1.*
2. *THE OFFICES OF PRESIDENT AND VICE PRESIDENT SHALL BE LIMITED TO TWO (2) CONSECUTIVE TERMS.*
3. *NOMINATIONS SHALL BE SUBMITTED, BY A PRESIDENTIAL APPOINTED NOMINATING COMMITTEE, AT THE TIME AND PLACE OF THE STATE CHAMPIONSHIP FIELD TOURNAMENT HELD IN THE ELECTION YEAR. FLOOR NOMINATIONS WILL BE ACCEPTED IN ACCORDANCE WITH ROBERTS PARLIAMENTARY RULES.*
4. *THE NOMINEES FOR EACH POSITION WITH THE HIGHEST NUMBER OF VOTES FROM THE D.S.A.A. MEMBERS, PRESENT AT THE D.S.A.A. ANNUAL MEETING, SHALL BE CONSIDERED AS ELECTED.*
5. *ANYONE UNDER THE AGE OF EIGHTEEN (18) CANNOT VOTE IN A D.S.A.A. ELECTION*

ARTICLE VIII : FEES AND DUES

1. ADULT MEMBERSHIP SHALL BE \$10 PER CALENDAR YEAR.
 - 1.a. 1ST AND 2ND ADDITIONAL MEMBER - \$4, 3RD AND 4TH ADDITIONAL MEMBER - \$2.
2. CUB ONLY, YOUTH ONLY AND SENIOR (65 YR.) ONLY SHALL BE \$8 PER CALENDAR YEAR.
3. LIFE SPOUSE MEMBERSHIP AND LIFE 2ND ADDITIONAL MEMBERSHALL FEES SHALL BE TWENTY FIVE (25) TIMES 1ST ADDITIONAL MEMBERSHIP AND 2ND ADDITIONAL MEMBERSHIP FEE, RESPECTIVELY.
4. CLUB AFFILIATION SHALL BE \$30 PER CALENDAR YEAR.

ARTICLE IX : AMENDMENTS

1. AMENDMENTS OR ALTERATIONS TO THIS CONSTITUTION MAY BE MADE ONLY BY HAVING THE SECRETARY SUBMIT, IN WRITING TO EACH MEMBER IN GOOD STANDIN, THE PROPOSED CHANGE, WITH NOTIFICATION THAT THE VOTING OF THE CHANGE WILL TAKE PLACE AT THE ANNUAL MEETING OF A SPECIAL MEETING CALLED FOR THIS PURPOSE BY THE PRESIDENT. MOTION WILL BE CARRIED BY MAJORITY OF THE MEMBERS PRESENT. VOTES WILL BE BY MAIL-IN BALLOTS.

ARTICLE X : STATE SHOOT SCHEDULES

1. D.S.A.A. SHALL PUBLISH A SCHEDULE OF ALL SHOOTS HELD BY MEMBER CLUBS OF THE D.S.A.A.
2. EACH CLUB SHALL SUBMIT A COPY OF THEIR PLANNED SHOOTS TO THE D.S.A.A. SECRETARY BY OCTOBER 31ST OF EACH YEAR.
3. THE STATE COMMITTEE SHALL MEET EACH YEAR IN NOVEMBER TO DECIDE ON DATES FOR THE STATE SHOOT.
4. THE SECRETARY SHALL MAIL or EMAIL ONE COPY OF THE STATE SHOOT SCHEDULE TO EACH D.S.A.A. MEMBER
5. THE D.S.A.A. SECRETARY SHALL NOTIFY, VIA EMAIL, FAX, OR REGULAR USPS MAIL, EACH D.S.A.A. AFFILIATED MEMBER CLUB'S SECRETARY OF THE STATE SHOOT SCHEDULE AND MAIL ONE HUNDRED (100) COPIES OF THE STATE SHOOT SCHEDULE TO EACH D.S.A.A. MEMBER CLUB. IT SHALL BE THE RESPONSIBILITY OF EACH D.S.A. MEMBER CLUB'S SECRETARY TO THEN NOTIFY ITS MEMBERSHIP OF SAID SHOOT SCHEDULE.

BY-LAWS OF THE DELAWARE STATE ARCHERY ASSOCIATION

ARTICLE I : MEETING OF THE EXECUTIVE COMMITTEE

1. *THE EXECUTIVE COMMITTEE SHALL MEET AS PRESCRIBED IN ARTICLE V OF THE CONSTITUTION.*
2. *THE PRESIDENTIAL APPOINTED COMMITTEES WILL MEET AT THE CALL OF THE D.S.A.A. PRESIDENT OR COMMITTEE CHAIRMAN.*
3. *EACH COMMITTEE CHAIRMAN WILL REPORT TO THE EXECUTIVE COMMITTEE AT THE MEETING ASSOCIATED WITH THE STATE CHAMPIONSHIP FIELD TOURNAMENT OR ANY OTHER TIME DIRECTED BY THE PRESIDENT.*

ARTICLE II : FEES AND DUES

1. *FEES AND DUES SHALL BE THOSE PRESCRIBED UNDER ARTICLE IX OF THE CONSTITUTION.*
2. *ANNUAL DUES ARE PAYABLE CONCURRENTLY WITH N.F.A.A. DUES.*
3. *D.S.A.A. MEMBERSHIP WILL BE SUSPENDED AT THE END OF THE MONTH FOLLOWING THE MONTH WHERE A MEMBER'S DUES RUN OUT. THE MEMBER MAY BE REINSTATED BY PAYMENT OF ANNUAL DUES.*
4. *ANY MEMBER DELINQUENT IN THE PAYMENT OF ANY DUES SHALL BE ELIGIBLE TO PARTICIPATE IN AN N.F.A.A. OR D.S.A.A. SANCTIONED TOURNAMENT, BUT WILL HAVE TO SHOOT IN THE GUEST CLASS.*

ARTICLE III : STATE CHAMPIONSHIP TOURNAMENTS

1. *ANNUAL FIELD AND INDOOR ARCHERY TOURNAMENTS SHALL BE CONDUCTED UNDER THE SPONSORSHIP OF THE D.S.A.A. AND OPERATED BY THE RULES AND REGULATION PRESCRIBED UNDER THE APPROPRIATE ARTICLES OF THE BY-LAWS OF THE N.F.A.A. THE TIME AND DATE SHALL BE ESTABLISHED BY THE STATE COMMITTEE.*
2. *THE TOURNAMENT ROUNDS SHALL BE IN ACCORDANCE WITH N.F.A.A.*
3. *THE STATE COMMITTEE, AT THEIR DISCRETION, MAY SCHEDULE D.S.A.A. SHOOT OTHER THAN THE FIELD AND INDOOR CHAMPIONSHIP, TO BE HELD AT VARIOUS TIMES OF THE YEAR.*
4. *NO D.S.A.A. RECOGNIZED CLUB SHALL SCHEDULE A TOURNAMENT ON THE DATES OF THE STATE CHAMPIONSHIP AND/OR STATE SPONSORED SHOOT.*
5. *STATE CHAMPIONS MUST BE CURRENT N.F.A.A. AND D.S.A.A. MEMBERS.*
6. *IN THE STATE CHAMPIONSHIP TOURNAMENTS, PARTICIPANTS WHO ARE NON-D.S.A.A. MEMBERS WILL NOT COMPETE AGAINST D.S.A.A. MEMBERS. THEY WILL COMPETE ONLY IN THE GUEST CLASS.*

7. ARCHERY CLUBS HOSTING A STATE TOURNAMENT WILL PROVIDE TO THE SECRETARY TWO (2) ASSISTANTS FOR REGISTERING ARCHERS AND POSTING SCORES. THE SECRETARY WILL MAKE ALL ENTRIES ON MEMBERSHIP-HANDICAP CARDS.
8. IN ALL STATE TOURNAMENTS, ARCHERS' TARGET ASSIGNMENT WILL BE ACCORDING TO STYLE AND CLASS, IN GROUPS OF 3 TO 5 PERSONS FOR THE FIRST DAY. THEY WILL BE GROUPED ACCORDING TO STYLE AND SCORE FOR ALL SUBSEQUENT ROUNDS, WHEN POSSIBLE.
9. THE SECRETARY WILL POST A COPY OF THE SHOOTING RULES AT THE REGISTRATION DESK DURING ALL D.S.A.A. SPONSORED TOURNAMENTS.

ARTICLE IV : CLASSES OF COMPETITION

1. CLASSES OF COMPETITION SHALL BE THOSE PRESCRIBED BY THE N.F.A.A. AND DEFINED IN ARTICLE VI OF THE BY-LAWS

ARTICLE V : OFFICIAL ROUNDS

1. THE FOLLOWING ROUNDS SHALL BE RECOGNIZED
 - A. FIELD ARCHERY – IN ACCORDANCE WITH N.F.A.A.
 - B. INDOOR ARCHERY – IN ACCORDANCE WITH N.F.A.A.

ARTICLE VI : CLASSIFICATIONS

1. CLASSIFICATION
 - A. FIELD ARCHERY – IN ACCORDANCE WITH N.F.A.A.
 - B. INDOOR ARCHERY – IN ACCORDANCE WITH N.F.A.A.

ARTICLE VII : CLASSIFICATION REGULATIONS AND PROCEDURES

1. THE UPKEEP AND MAINTENANCE OF MEMBERSHIP HANDICAP CARDS SHALL BE CENTRALLY CONTROLLED BY THE D.S.A.A. SECRETARY.
2. TEMPORARY CARDS SHALL BE ISSUED BY THE APPROPRIATE CLUB AT THE COST OF N.F.A.A. AND D.S.A.A. DUES.
3. TEMPORARY CARDS SHALL BE DATED AND WILL NOT BE EFFECTIVE AFTER 30 DAYS OF ISSUANCE, OR UPON RECEIPT OF THE PERMANENT CLASSIFICATION CARDS MAILED TO THE INDIVIDUAL BY THE SECRETARY, WHICHEVER SHALL OCCUR FIRST.
4. CLUB SECRETARIES SHALL, WITHIN FIVE (5) DAYS, SEND ANY SURRENDER MEMBERSHIP-HANDICAP CARDS TO THE SECRETARY. THE SECRETARY SHALL SEE THAT THE PERMANENT CLASS CARDS ARE MAILED TO MEET THE 30 DAY TIME LIMIT.
5. ALL SCORES NOT ON OFFICIAL CLASSIFICATION ROUNDS SHALL BE RECORDED ON THE MEMBERSHIP-HANDICAP CARDS OF BOTH RESIDENTS AND NON-RESIDENTS.
6. YOUTH ARCHERS COMPETING IN ADULT CLASSES WILL BE IN ACCORDANCE WITH N.F.A.A.
7. ANY ARCHER SHALL HAVE THE OPTION OF COMPETING IN ANY HIGHER CLASS.
8. WOMEN MAY COMPETE IN THE MEN'S CLASS, BUT NOT VICE VERSA.

9. *ANY INFORMATION RECORDED ON AN ARCHER'S MEMBERSHIP-HANDICAP CARD SHALL BE ENTERED IN INK. IN THE EVENT THAT CORRECTIONS MUST BE MADE, A LINE SHALL BE DRAWN THROUGH THE ERROR AND INITIALLED BY THE PERSON RESPONSIBLE FOR THE CHANGE. THE LINE USED SHALL BE NARROW ENOUGH TO ALLOW CLASSIFICATION OFFICIALS TO SEE WHAT THE ORIGINAL RECORDING WAS.*
10. *AN ARCHER CANNOT CHANGE IN CLASSIFICATION DURING A TOURNAMENT.*

ARTICLE IX : SHOOTING RULES

1. *FIELD ARCHERY AND INDOOR ARCHERY – IN ACCORDANCE WITH N.F.A.A.*
2. *EQUIPMENT INSPECTION WILL BE UPON PROTEST, OR AT THE DISCRETION OF THE N.F.A.A. DIRECTOR.*
3. *PROTESTS MUST BE LODGED WITH A STATE OFFICER BEFORE THE CONCLUSION OF THE TOURNAMENT.*

ARTICLE X : STATE SHOOT FEES

1. *STATE SHOOT FEES SHALL BE DECIDED ON BY THE EXECUTIVE COMMITTEE.*
